
Is your wife-line organized?

Is this Milo Andrus?

Well again, no. This is a picture of G. Merrill Andrus, president of the Milo Andrus Family Organization, as he appeared at the Commemoration of Mormon Grove in Atchison, Kansas on Saturday, 23 July 2005. The Family participated with youth and adults from the Topeka Kansas Stake and the Platte City Missouri Stake in this gathering. This program was held in the O'Malley-McAllister Auditorium of the Benedictine College at 1020 North Second Street in Atchison. This picture appeared on the front page of the Atchison Daily Globe newspaper along with a nice article by Mary Meyers a reporter for the paper. A follow-up article by Ms. Meyers appeared in the same paper on Wednesday, 27 July and we have copied it below.

Mormon heritage deserves recognition

As I write this column I continue to bask in the afterglow of my Mormon experience last weekend. Their wealth of and respect for genealogy was a breath of fresh air compared to some of the "who cares about that stuff" attitudes I've encountered from some throughout my life.

I'm even more amazed at how much so many of these people out of our area know more about 300 acres of land on the backside of Atchison than we locals do.

According to their historical accounts, Atchison was very new and when the Mormons arrived, only six houses had been built in Atchison. The initial town fathers relied on Mormon cooperation to build much of the initial infrastructure that paved the way for successful commerce and enterprises.

From what I gather, family genealogy is not only important to them personally, but many Mormons consider their family histories as a testament to their faith. After the Mormons arrived and stepped off the flat river boats and steamboats, they traveled to the hickory tree grove and divided themselves according to their nationality and stayed within their respective camp in the encampment.

On display was an exhibit about Mormon Grove, the designated outfitting post in 1855 for Mormons involved in the Perpetual Emigrant (sic) Fund, a revolving fund to help emigrants migrate to Utah. The exhibit was compiled by Laura Anderson, Utah, who had been to Atchison twice before to research the Mormon connection.

Mrs. Anderson was costumed as a Danish emigrant. I noticed her exhibit was very similar to a folklore and heritage exhibit I've been involved with concerning the St. Patrick's Church pioneers and what was at St. Louis Church—so I guess we're right on track with showcasing our heritage.

Mormon pioneers might reflect different individuals, ethnic or religious groups, circumstances and destinations. However, their stories are basically the same as our ancestors in Good Intent, Saint Patrick's, Port William, Sumner, Atchison and other towns in the county. They're all about perseverance, family and adventures on a new frontier.

What's admirable of the Mormons is that so much of the genealogy is intact and readily accessible to interested individuals.

My first brush with the Mormons came in 1999, when I did a story on the 150th celebration of the San Francisco Gold Rush. About half of the travelers were from Utah and had an affiliation with the Church of Jesus Christ of Latter-day Saints—they were aware of Mormon Grove.

A highlight of my recent interaction came later in the afternoon when I took a little jaunt to the Mormon Grove marker along U. S. Highway 73, about four to five miles west of Atchison. It was quite a chance meeting, but while there I caught up with a caravan of vehicles. Heading up this entourage was Dea Yanke, who shared some generational family stories told to her by her "Grandpappy," Roy Reid.

From the marker we traveled north on Osage Road and stopped at a bridge over Deer Creek near a sharp curve in the valley. There Dea pointed toward the direction where she was told the early Reid family pioneers would watch the Mormons load their wagons with spring water for their 1,000-mile, 100-day journey to Utah.

For the visitors it was a meaningful sight and it was apparent their were on a sentimental journey of their own—very moving.

Newton & Juletta Andrus Family Reunion

The posterity of Newton and Juletta Andrus participated in a family reunion at the site of Newton's family homestead in Milo, Idaho, 27 Aug 2005. Newton was the son of Milo and Jane Munday Andrus and one of three brothers and a sister (Josephine, Heber and Robert are the others) who eventually made their home in the Idaho Falls area. Newt and Lettie had ten children: Les, Golden, Zina, Rose, Arveta, LaMar, Verda, Emil, Lois and Ivan. Only Ivan's wife, Jean, and Golden's wife, Norma, are living. Jean was able to attend the reunion.

Festivities began at 11 a.m. at the Milo Ward outdoor pavilion. Name tags were donned, the family database was updated and everyone ate lunch. Things were going very smoothly until the lawn sprinklers came on in the middle of the picnic. However, with a bit of ingenuity that Grandpa Newt would have been proud of all was put in proper order and not a mouthful was missed.

The group was welcomed by reunion chairman Newt Andrus (son of LaMar) who gave a brief life sketch of Grandpa Newt and Grandma Lettie. Then a representative of each of Newt's and Lettie's ten children presented reminiscences from their parents, histories about growing up in southeastern Idaho.

Hyrum recounted the time when his father, Les, was miraculously saved when a shot gun he was cleaning misfired. Les and Golden always went hunting and fishing together and took any excuse to sing along with Ivan and Emil. It was related that Zina was an excellent seamstress who designed and made clothes for herself, her sisters and her daughter, Nita. Renee King Harris told a fun story about her mom, Rose, and Zina, who were very close. They entered the local spelling bee and ended up having to spell off against each other for the championship. After several words each, they agreed to end in a tie.

Lamar, s granddaughter, Amy, related how her grandpa always took her on outings to feed the ducks and float toy boats in the irrigation ditch. Sandra Christopherson related how her mother, Verda, told about, the making of washday soup.

Andrea, Emil's daughter, didn't, know Grandpa and Grandma Andrus, but remembers her dad reading the Bible to her when she was young. Judy, Lois's daughter, remembered Grandma Lettie coming to live with them when she was older. She walked with her crutch upside down. Judy also told stories of all the kids swimming in the Snake River and diving off the bridge. Finally, Gayle, Ivan's daughter, told of her dad's love of fishing and singing--traits learned from Newt and Lettie.

Laura Anderson next brought everyone up to date on recent progress in family history research, which was amazing. The reunion ended with the taking of family pictures and a self-guided tour of the family homesteads (Ucon, Milo, Chester, Ora, Popular, Roberts and J Street in Idaho Falls).
