## Faith of Our Fathers: A Tribute to Pioneer Milo Andrus

n July of 2011, my family and I spent a weekend in Salt Lake City celebrating the life of Milo Andrus, my greatgreat grandfather, a man heralded as an extraordinary pioneer. As we recounted his life, we honored him with songs and stories, reminiscent of so many, who, through their faith, dedicated their lives to build a land for their posterity.

For seven years, Milo Andrus resided under the warm Dixie sun, a place I now call home, when Brigham Young in early 1874 invited him and other leading men to travel here to southern Utah help each child say a prayer. to initiate a cooperative movement. Their objectives included "the general business of farming, manufacturing, fruit growing, stock raising, dairying, and as many other pursuits as will fulfill the material prosperity of all."

In 1861, when 306 families were asked to move their homes from northern to southern Utah, Milo Andrus had just returned to the Salt Lake Valley after having served a second mission to England. He was not asked to pioneer southern Utah at that time, but he was delighted that his eldest son James was among those requested to break new ground here.

These were hearty pioneer men and women with the "strength of God in their souls." Many of their descendants still live in southern Utah, a place that today has become one of America's fastest growing cities, but one can only imagine what these early settlers thought when they first looked down from the bluffs—aloud an eight-stanza tribute entitled "Charlie's Farewell to Milo." into the Virgin River Valley seeing few trees and little water, but plenty of black rocks, red sand, rabbit brush, and mesquite. The magnitude of their tasks was great indeed. By the time Milo Andrus arrived, the early settlers had labored for ten years to build a new city. A tabernacle had been built at a cost of \$110,000 and plans were underway to build a temple.

Milo Andrus noted he was "at work on the temple, which is progressing very well. There are over one hundred men engaged directly on the ground, over one hundred working in the quarry, and over forty men at Mount Trumbull getting out lumber. n addition, some men are on the road for the purpose of getting wood, coal, etc."

Milo Andrus frequently spoke in the Tabernacle. His good friend Charles L. Walker, known as "the poet laureate of Dixie," records in his journals 32 instances when he heard Milo speak. He included such comments as "Brother Milo spoke to us in a very interesting manner, showing the importance that the Saints know

for themselves of the divinity of the work in which we are engaged." His knowledge of Church history, the stories of the Book of Mormon, and the importance of unity among the Saints were just some of his remembered sermons.

Music held a special place in the life of Milo Andrus and his family. Over a three-week period when they moved from Salt Lake to St. George, and as they camped along the path, each night before retiring, Milo would lead his family in an evening hymn and

It was a sad day for Milo Andrus and his family when friend George, Q. Cannon, first counselor to President John Taylor, asked him leave Dixie "to strengthen the borders of Zion on Green River." He loved southern Utah and the people loved him. According to historian Ivan J. Barrett, who wrote a biography of Milo Andrus: "From my study of Church history, I ... have found no one among the Mormon colonizers of the West who was a more admired, respected, and sought-after speaker than Milo Andrus."

Incidentally, Milo Andrus carried watermelon seeds with him to Green River and planted the first watermelon there. What a succulent harvest the settlers must have experienced! Even today in Dixie, on a warm summer evening, a watermelon bust is not complete without Green River watermelons.

Before Milo's departure, Walker penned and publicly read One stanza of particular note reads:

When I say farewell to thee, The heartstrings seem to bend: In parting with our tried and true, To God, and man, a friend. Yea, one whose life so nobly spent For Zion and the weal: And only those who know the best Can sense how keen they feel.

Selected excerpts are taken from the book *Trumpeter of God:* Fascinating True Stories of the Great Missionary and Colonizer, Milo Andrus by Ivan J. Barrett, printed in 1992 and dedicated to the family and descendants of Milo Andrus.
